CERTIFICATE OF INSURANCE:

All teams and/or organizations must carry a minimum of \$1,000,000 in general liability coverage per occurrence and supply a Certificate of Insurance naming the following as additional insured. Proof of this coverage must be on file with the Town of Dyer Parks and Recreation office *prior* to any use of fields or facilities. All Certificate of Insurances must list the Town of Dyer Parks Department as additional insured.

OTHER CONSIDERATIONS:

1. Permitted athletic field users are responsible for maintaining the fields in a safe and responsible manner when using them. Fields should be checked before and after each use to ensure they are safe for use.
2. The parks and recreation department will mow the grass on the fields and empty trash cans, but all other field maintenance is up to the permitted organization or team.
3. Users are responsible for cleaning the field, dugout, and spectator areas after completion of each use.
4. Field Permits are non-transferable.
5. Field Permit fees are refundable as per the Town of Dyer Parks and Recreation Refund policy which is available upon request.
6. Facilities may be closed by the Town of Dyer in times of inclement weather to preserve the long-term health of the facility.
7. Vehicles are not allowed to be on the grass or the paved walking paths. Parking in adjoining neighboring subdivisions is prohibited when using the parks. Park users should only park in designated areas which are the park parking lots.

8. Soft toss is not allowed against any fence in Dyer Parks. The only exception to this rule is the use of whiffle balls.
9. No alcohol is allowed in the parks.
10. Any use of loudspeakers or public address instruments is strictly prohibited except by special written permission from the Town of Dyer Parks and Recreation Department. The Town of Dyer Parks and Recreation Department may cancel a permit for use of amplified equipment at any time.
11. A refund of rental fees is subject to a service charge. A full refund will be granted if inclement weather conditions result in the Town of Dyer Parks and Recreation Department cancelling the permit.
